**WILD COW MILKING RULES**

1. Two person team. In the event of an injury to a contestant on Thursday night, that contestant may be replaced for Friday night upon approval of Wild Cow Milking director. This applies only to injury and must be determined Thursday night. In the event the Wild Cow Milking director allows an injury replacement, that team still qualifies for the all around championship.
2. Start from a standing position. All contestants in a line.
3. Each team will have an official assigned to them to watch that specific team for any rules violations that would cause disqualification.
4. Each roper must rope his numbered cow as determined by random draw. Cow must be roped around the neck. Any leg catches are illegal and will cause immediate disqualification. Cow will not be dragged. If cow is dragged more than 5 feet, that team will be immediately disqualified.
5. Rope must be removed from the saddle or your cow's neck after cow is mugged.
6. Roper must milk the numbered cow he drew and roped.
7. He will run back to the judges circle.
8. Bottle must drip milk. Your time stops when the bottle drips. Placement is by which team's bottle drips first. Decisions of the arena judge are final and may not be protested.
9. Payoff:           1<sup>st</sup> place \$500 per team  
                          2<sup>nd</sup> place \$300 per team  
                          3<sup>rd</sup> place \$200 per team

Payoff is based on minimum of 8 teams. Purse will be adjusted accordingly in the event of less than 8 teams.

10. **Any team caught cheating (i.e. creamers, spitting in bottle, milk hidden) will be disqualified immediately from the event and escorted off the grounds and will be permanently barred from any participation in the Desertview Pro Rodeo or its activities or events.**
11. Each team member must sign and return a copy of the rules acknowledging and agreeing to abide by the rules and officials decisions. One copy of rules for contestants and second copy must be signed and returned with entry forms and fees.
1. Only contestant and one companion will be allowed gate access.
